## **OPERATION ROUND UP® GRANT GUIDELINES**

### **PURPOSE**

The South Central Electric Trust will be funded by voluntary Operation Round Up contributions from members of the Cooperative and from other sources of funds available to the Trust. Grant availability will be promoted to area communities and organizations. Contributions will be distributed in the local area served by the Cooperative for charitable and educational purposes.

The Trust Board will review and distribute funds each November and April.

Application deadline is March 18, 2022. Applications must be postmarked by these dates and mailed to South Central Electric Association, P.O. Box 150, St. James, MN 56081, or turned in to South Central Electric's headquarters at 71176 Tiell Dr. in St. James by the close of business (3:30 p.m.) on the date of each deadline, to be eligible for consideration in conjunction with the schedule listed above.

### **ELIGIBILITY:**

1. Contributions will generally be made to nonprofit, civic or community-based organizations that demonstrate a commitment to enhance the quality of life in the region.
2. Contributions will be distributed in the local area served by the cooperative.
3. Projects should fit in one or more of these categories: Community Service, Education and Youth, Community Economic Assistance, Environment, Emergency Energy Assistance and Disaster Relief.

### **LIMITATIONS:**

1. Contributions will not be made for lobbying or political organizations.
2. Contributions will generally not be made for:
  - a. Veteran, fraternal, religious and labor organizations.
  - b. Fund-raising dinners, raffles and other events.
  - c. Individuals (except school scholarships, emergency assistance and disaster relief).
  - d. Capital fund campaigns.
  - e. National fund drives.
  - f. Advertising.
  - g. On-going operational expenses.

**EVALUATION FACTORS**

1. The following factors will be considered in the evaluation of all funding requests:
  - a. Potential benefit to area residents and the entire community;
  - b. Level of community support for the program or project or the organization requesting the funds;
  - c. Administrative capability of the organization to deliver quality service or program;
  - d. Results that are predictable and can be evaluated.
  
2. It shall be the responsibility of all Trust directors to evaluate funding requests and allocate contributions to accomplish the purposes and intent of these guidelines.

**REQUIREMENTS:**

1. Complete application form.
2. Provide detailed budget demonstrating:
  - a. How grant funds will be spent on this project or program
  - b. Sources and uses of existing program funds
3. Submit copy of the IRS tax-exempt letter, if appropriate.
