Affiant, as the claiming successor, is entitled to collect the following described property to-wit: all equities/capital credits of Decedent with South Central Electric Association (including reissuance of uncashed capital credit checks originally issued to Decedent by unclaimed capital credits).

8. I hereby request payment or distribution of all of the above described property as follows (check and complete Box A or B):

## NOTICE

Notice to the person claiming capital credits or funds from South Central Electric Association on behalf of a deceased person/owner of capital credits or funds:

1. Please be advised that if the estate of the deceased person owning the capital credits is being probated in the Court or will be or is required to be probated in the Court, then the Affidavit for Collection form discussed in the following paragraphs cannot be used and if the estate is probated the Court appointed Personal Representative of the estate must sign papers to receive the capital credits.
2. If there is no probate proceeding of the Decedent's estate, then if you are a proper successor to the deceased person, you may complete and sign the Affidavit for Collection form and attach a copy of the deceased person's death certificate and present the forms to South Central Electric Association. Your signature on the Affidavit for Collection form must be notarized.

In most cases, the successor will be the spouse or a child of the Decedent. It is up to you and/or your family to determine who is the correct and proper successor to sign the documents. South Central Electric Association cannot help you with this determination.

32. Keep in mind, if you are collecting the property from South Central Electric Association, you are agreeing to distribute the property according to the probate rules which means the property is first to be used to pay debts of the Decedent as specified in the probate statutes (Minn. Statutes Chapter 524) and then any remaining property is to be distributed according to Minnesota law. South Central Electric Association cannot help you with determining any of the above.
4. By signing the Affidavit for Collection form, you are personally indemnifying and holding South Central Electric Association harmless and free from any liability whatsoever in connection with South Central Electric Association's distribution and payment of the property to you.
5. A form is included to assist you in completing the forms.
